Grants up to \$500 will be awarded to conduct waste reduction awareness projects. Up to \$5,000 in grant funds will be made available to community schools each year.

**Application Guidelines**

1. Maximum amount granted will not exceed \$1,500.
2. Proposals are submitted in duplicate.
3. Application must be submitted on Grant Application Forms-General Information, Purchase List, Project Description.
4. Deadline is 4pm, **November 15, 2023**. Grants will be reviewed within a 30- day period.
5. Funding decisions will be made by the Miami County Solid Waste District. Applications that show program longevity will be given the highest consideration.
6. Funding must be used within one year of approval.
7. A summary report must be submitted to the District within a grant approved stated deadline.
